Enhancement in Rates/ Tariffs for Holiday Homes

It has been observed by the Members of the Staff Welfare Committee that the Rates for Holiday Homes situated at different places have not been revised for a long time though the reviews have been made. But considering the convenience of the esteemed members, the Tariff of the Holiday Homes have not been revised and the Tariff /Rates of Holiday Homes are still very less, whereas the Overhead expenditures towards Holiday Homes including the Rent payable to the Hotels by the SSWFM have become enhanced to a large extent. Even, In case of Puri Holiday Home, Overhead / Capital expenditures viz. Electricity Charges, LPG Cooking Gas Cost, Govt. Rent etc. have also been increased and for renovation of the Building, a sizable expenditures have also been incurred comparing to the services provided. But to maintain the Holiday Homes in exchange of the existing cheaper rate, there are serious uncertainty to continue to render the service of the Holiday Homes. However, though to provide the Holiday Homes at a cheaper rate to the members of the Bank is the motto of the Management, there is no other alternate way to continue to provide Holiday Home Service only by enhancing the Tariff to a small extent.
