- III. Hosting must be on a **Dedicated Private Linux Server** (Shared server not allowed).
- IV. Vendor must provide continuous technical support and monitoring 24*7.
- V. Full root Access required.

- Copy of supporting documents related to Technical specification as mentioned in **Point No. A to D**.


G. Financial Bid: The bidder is to provide the financial Bid in Financial Bid envelope.
